This letter accompanies the application form for a Camp Mennoscah summer staff position. The summer staff positions are: crafts leader, music leader, lifeguard, assistant lifeguard, naturalist, office assistant, and maintenance/grounds.

Our 2010 summer camp season runs from May 31/June 1 to August 7. Actual summer camps begin June 6. Summer staff is expected to be at camp the week before camps begin for orientation and to stay up to one week after camps are over. The summer staff salary is \$200 per week.
